तिरुवनंतपुरम के जिला प्रशासन ने शहर में पूर्णबंदी को जारी रखने का फैसला किया है। इसके साथ ही

आजीविका सुनिश्चित करने और दिन-प्रतिदिन की

गतिविधियों को बहाल करने के लिए कुछ प्रतिबंधों में ढील देने का भी निर्णय लिया है। कोरोना से संक्रमण के बढ़ते मामलों के बाद शहर में पांच जुलाई से पूर्णबंदी लागू है। वहीं महीने की शुरुआत में ही अधिकारियों ने कोरोना संक्रमण के सामुदायिक प्रसार की पुष्टि की थी, जिसके बाद जिले के दो तटीय क्षेत्रों को निरुद्ध क्षेत्र

घोषित किया था। राज्य सरकार ने राजधानी में पूर्णबंदी के प्रतिबंधों में ढील देने पर एक रिपोर्ट प्रस्तुत करने के लिए मुख्य सचिव की अध्यक्षता वाले पैनल की नियुक्ति की थी। जिला कलेक्टर डॉ. नवजेत खोसा ने मंगलवार देर रात जारी आदेश में कहा, ‘जिले में अगले आदेश तक पूर्णबंदी जारी रहेगी।’
